This three day trade show held in Boston attracts over 20,000 total attendees from more than 100 countries. SUSTA invites our companies to meet one-on-one with key Canadian buyers, importers and distributors during the second day of the show. SUSTA's in-country Canadian market representatives will also be able to provide valueable market overviews and market information.

Brussels, Belgium - April 25-27, 2017

Participation Fee: \$6,150.00

Brussels hosts one of the largest seafood expos in the world. Seafood Expo Global brings together over 28,500 buyers, and 1,700 exhibiting companies from more than 75 countries. Your fee includes: 10 square meter hard wall booth space, booth furnishings (carpet, table, two chairs, sales counter, two stools, signage and electricity), ice and overnight cold storage available, 100lbs sample shipping allowance from a consolidation point in the US to the show using SUSTA's designated freight forwarder, and a chef is available on-site to prepare samples. Through 50% CostShare companies can apply for 50% reimbursement of the participation fee and travel for two company employees or representatives.
